
- 1. **Call to order** Annual General Meeting (AGM) called to order by Mary Williams, President of the NBART at 1941.

a) <u>Executive Report</u> – The Executive report was given by Mary Williams, President of the NBART.

With the enactment of the Provincial Emergency Mandatory Orders, under the By-law 14.10 Emergency Registration, we have provided temporary licenses to RT's providing care in COVID-19 assessment and vaccination centers.

Worked with GNB and Public Health to include RRT's in the Medical Directive for the Provision of COVID-19 Immunization

Participated in Health Plan Engagement Session with the Minister of Health. It provided an opportunity for regulators and professional associations to provide input into the vision for the new health plan to be released by GNB

We continue to maintain and update the COVID-19 section on our website as new information becomes available to help RTs stay informed

The NBART issued a letter of support to the University of New Brunswick (UNB) for the development of a new undergraduate program, Bachelor of Health Sciences (Respiratory Therapy) Post Diploma Entry at UNB Saint John. This proposed program will enable RRT's in NB to achieve another level.

As reported last year, the NBART is a Provincial Program Client with EQual™ Canada Allied Health Education Accreditation that provides accreditation services to our schools in New Brunswick. Troy Denton represents the NBART on the EQual™ Program Council. We would like to congratulate members of our association who have become Accreditation Surveyors.

As part of the implementation of the strategic plan, the Board completed a detailed action plan to reach our strategic goals of good Governance, enhanced Professional Standards, Communication and Operations for our Association over the next 4 years.

As a thank you for your dedication this spring, the association provided members with an NBART RRT mask.

Due to the Pandemic the AGM for the National Alliance of Respiratory Therapy Regulatory Bodies was postponed to November 26, 2021. The NARTRB has established several working groups including simulation, harmonization, standards of practice and code of ethics in which the NBART will participate. Over the next 2 years, the NARTRB will work toward review and development of the National Competency Framework for Respiratory Therapy.


